Note 1: In relation to the figures of production, it is informated that the 31,000 tonnes of FFB achive a CPO production with an extaction of 21.8% the achieve an estimated production of 6,758 tonnes estimated, however including the production of all suppliers that the extraction plant has, production estimated is of 10.700 tons/year.

Note 2: The hectares on which the LUCA studies were carried out are 2,794.86 but in this first audit only 2,208,91 hectares will be certified.
